  - 4.2 Budget Presentation James Zavas
    - James presented the Adopted Budget for 2020-21 as of 8/31/2020. He mentioned there will be Budget Forums Zoom meetings in early October before the BOT adopts a budget at their October 8 meeting. We saw the Fiscal Projections for 2021-22, 2022-23, 2023-24, and 2024-25. The Key Assumptions included: State Revenue budgeted based on 2019-20FTES-minimum funding level, International Tuition Budgeted with a 60% decline from 2019-20 \$4.5 million, Out-of-State Tuition budgeted with a 45% decline from 2019-20 \$1.2 million, Smaller Schedule reduces expenses by \$3.3 million, SRP providing \$1.88 million in savings, General Fund Backfilling Parking and Food Service Operations \$1.35 million, State Apportionment Deferral of \$17.1 million impacts District's cash flow. The District has more than sufficient cash to address the planned deferral. James asked us to email him with any input we have regarding his presentation.
